GENERAL RELEASE, HOLD HARMLESS AGREEMENT AND COVENANT NOT TO SUE

This GENERAL RELEASE, HOLD HARMLESS AGREEMENT AND COVENANT NOT TO SUE (hereinafter "Release") is executed by the **UNDERSIGNED**, with the intent of binding the undersigned, its respective affiliated entities, officers, agents, representatives, current employees, attorney, successors and assigns and insurance carriers (hereinafter collectively referred to as the "Undersigned"), who knowingly, intentionally and voluntarily executed this Release in favor of the **HENRY COUNTY WATER AUTHORITY**, its members, officers, agents, and employees (hereinafter the "Authority")

IN CONSIDERATION of the Authority issuing to the Undersigned a **PERMIT TO FISH** and **PERMIT FOR USE OF AUTHORITY FACILITIES** on the Authority's designated Reservoir(s) and Reservoir Areas in Henry County, the receipt of which is hereby expressly acknowledged:

1. The Undersigned does hereby agree to release and discharge the Authority and Henry County, Georgia from any and all claims, counterclaims, and other causes of action, whether known or unknown, whether at law or in equity, in any manner arising out of any claim or injury asserted or which might have been asserted between the Undersigned and the Authority and Henry County, Georgia herein, including but not limited to those claims that might arise as a result of the Undersigned's use of the Authority's and Henry County's property and Reservoirs.
2. The Undersigned specifically waives any rights that the Undersigned might have had under the Constitution of the United States or any of the several States, Federal or State statutory law and/or any regulations issued in regards thereto, and specifically as to the unknown or unsuspected claims arising out of the above-referenced use.
3. Neither the Undersigned nor his/her spouse, children, heirs, representatives, attorneys, successors or assigns will ever institute any other action or suit at law or in equity against the Authority or Henry County, Georgia, or institute, prosecute or in any way aid in the institution or prosecution of any claim, demand, action or causes of action, civil or criminal, for damages, cost, loss of services, expenses or compensation for or on account of any damage, loss or injury either to person or property or both, whether developed or undeveloped, resulting or to result, known or unknown, past, present or future, arising out of the above-referenced matters.
4. The Undersigned does hereby agree to hold the Authority and Henry County, Georgia harmless from any damage, loss or expenses in regard to any failure of the Undersigned's, its respective affiliated entities, officers, agents, representatives, current employees, attorney, successors and assigns and insurance carriers to comply with either the spirit or letter of this Release.

By signing the waiver, I hereby grant HCWA and their representative's permission to take and publish photographs of me and my party at this event.

This Release shall become effective upon signing of the Undersigned.
